PURPOSE

The Brody Building Open House was conducted in the front entrance to the Brody Building on September 2, 2009 between 11:30 a.m. and 1:30 p.m. The purpose of this open house was to gather input in an open forum to identify concerns and relevant issues relating to the ECU Comprehensive Plan. This Open House was specifically focused on the West /Health Sciences Campus, although issues were brought up that relate to both of the physical campuses, as well as their relationship to one another. An electronic invitation went out campus-wide to invite students and faculty to discuss issues with the planning team.

The SmithGroup/JJR team solicited information through two simple, and engaging exercises. With the first exercise, attendees are asked to identify their favorite places on campus and least favorite places on campus. This exercise requires participants to vote using red (least favorite) and green (most favorite) dots on campus maps. Participants were given 2 red and 2 green dots to place on the maps. The SmithGroup/JJR team guides this exercise and gains an understanding of why these places are generally good or generally bad. The second exercise allows people to respond to with questions and concerns relating that address anything from campus image, transportation, security, student life, to buildings and facilities.

Participants are invited to "post" their thoughts by jotting their questions/concerns on "post-it" notes and sticking them on a comment board. This exercise allows people to voice what they value in a campus context from physical features and amenities, to topics such as safety and security.
